#### Role of the School Board is to:

## **Role of the Principal:**

- Promote the Caritas College Health Care and Medication Policy
- Monitor the implementation of the policy and procedural guidelines in relation to student wellbeing and healthcare
- Implement the SACCS and Caritas College Enrolment Policy, in particular the New Enrolment Support Procedure (NESP) and the Department for Education and Child Development (DECD) - child health and education support services (chess) <u>http://www.chess.sa.edu.au/</u>
- Create partnerships with family and health professionals to support student wellbeing and health care
- Allocation of resources to support student health and wellbeing
- Ensure the policy is implemented in accordance with related SACCS policies
- Support staff in implementing the policy
- Ensure staff members received relevant training in areas related to Health Care.

#### Role of Families is to:

- Work collaboratively with the College and where applicable, with health professionals in the best interests of the student by providing relevant and updated information
- Inform College staff of any change of circumstance that relates to the health care and wellbeing of students
- Actively participate with College staff in the development and maintenance of a Health Care Plan.

#### Role of Staff Members is to:

- Remain informed of updated information and Health Care plans
- Attend First Aid training and other relevant training
- Fulfil all requirements in relation to WH&S legislation
- Impart a duty of care at all times
- Ensure modifications are made to learning programs as a result of medical information and Health Care plans
- Take responsibility for communicating Health Care information and observations to families and other staff.

#### Role of Students is to:

- Fulfil their responsibilities provided in the Health Care Plan
- Inform school staff and family of any concerns or issues arising in relation to health and wellbeing.
